Legal Decisions

As the Proper Officer of the Council it is my duty to again remind Members that Motions need to be received from Councillors in order for decisions to be taken.

Please see Standing Order 3(b) for details.

A Council cannot lawfully decide any matter which is not specified on the Agenda (Local Government Act 1972 Schedule 12). The Summons must specify the business to be discussed in such a way that the member receiving it can identify the matters which he/she will be able to discuss.

In addition Members must submit any questions they wish to be answered at the meeting in advance as laid down in the new Standing Orders 8(a).

No individual Councillor shall issue orders instructions or directions to staff: Staveley Town Council is a corporate body as Standing Order 23(ii) makes clear. Delegation to individual Councillors is illegal.

If there are any proposals arising from individual Councillors then the procedures set out in Standing Orders must be followed. They should be submitted to me for inclusion on the Policy Finance and Publicity Committee Agenda to go forward to the next Ordinary Meeting or direct to the next Ordinary Meeting.

I trust this clarifies the legal situation regarding how Staveley Town Council may legally take decisions.

I have been contacted regarding work or expenditure on the Heart of Staveley Project: some Members believe it was agreed that no more work or expenditure on the Heart of Staveley Project should be incurred until we had met with Chesterfield Borough Council over their Report.

However, Standing Order 4 (a) states that "no motion may be moved at a meeting unless it is included in the Agenda and the mover has given written notice of its wording to the Council's Proper Officer at least 5 clear days before the next meeting".

The time limit of 5 clear days is in fact not achievable as under Standing Order 3(b)(i) the Agenda has to be served at least 7 clear days before a meeting.

No motion was received on this matter before the meeting and accordingly Standing Orders mean that there is currently no ruling on ceasing work or expenditure on the Heart of Staveley Project.

Any Elected Member who wishes this to become a resolution of the Council should submit it in writing at least 7 clear days before the next meeting so it may be included on the agenda.

That the Members of the Sub-Committee are to be the Leader of the Council (Councillor Ludlow), the Chair of the Policy, Finance and Publicity Committee (Councillor A. Hill), the Deputy Chair of the Policy, Finance and Publicity Committee (Councillor D. Collins), the Chair of the Council (Councillor Dyke), together with Councillor Parsons.

That the Sub-Committee have delegated powers to choose from any bids between £7,000 to £12,000.

At this point the Chair reintroduced Standing Orders and the public were invited back into the room.

At a meeting with Councillors Ludlow and A. Hill on 4th April it was agreed as there was no urgent business the meetings of the Leisure and Community Committee and Policy Finance and Publicity Committee scheduled for 17th April would be cancelled.

On the 9th April I attended a Photo Opportunity at the new housing development on Frecheville Street with Guinness Northern Counties. A copy of the resultant Press Release has been circulated.

On the 10th I attended the meeting of the Friends of King George V Park at which John Ramsey and Andy Pashley represented Chesterfield Borough Council.
